Pursued efforts to purchase land and two houses for affordable housing development in non-minority areas of the Dallas Metro Area.

Dews Dell LLC/Land purchase - ICP formed and is the sole member of Dews Dell LLC, a Texas Limited Liability Company which purchased land in a suburban town for the development of affordable housing for low income families, and to address and remove land use policy barriers to the development. The town was previously found by a federal judge to have engaged in racially discriminatory land use and zoning practices to prevent the development of affordable housing for such families. The financial activities of Dews Dell are reflected in the financial statements of ICP.
